Plywood/OSB roof sheathing with a minimum thickness of 7/16" inch attached to the roof truss/rafter (spaced a maximum of 24" inches o.c.) by 8d common nails spaced a maximum of 6" inches in the field. **-OR-** Dimensional lumber/Tongue & Groove decking with a minimum of 2 nails per board (or 1 nail per board if each board is equal to or less than 6 inches in width). **-OR-** Any system of screws, nails, adhesives, other deck fastening system or truss/rafter spacing that is shown to have an equivalent

  - Metal connectors consisting of a single strap that wraps over the top of the truss/rafter **and** is secured with a minimum of 2 nails on the front side and a minimum of 1 nail on the opposing side.
- D. Double Wraps
  - Metal Connectors consisting of 2 separate straps that are attached to the wall frame, or embedded in the bond beam, on either side of the truss/rafter where each strap wraps over the top of the truss/rafter **and** is secured with a minimum of 2 nails on the front side, **and** a minimum of 1 nail on the opposing side, **or**
  - Metal connectors consisting of a single strap that wraps over the top of the truss/rafter, is secured to the wall on both sides, **and** is secured to the top plate with a minimum of three nails on each side.

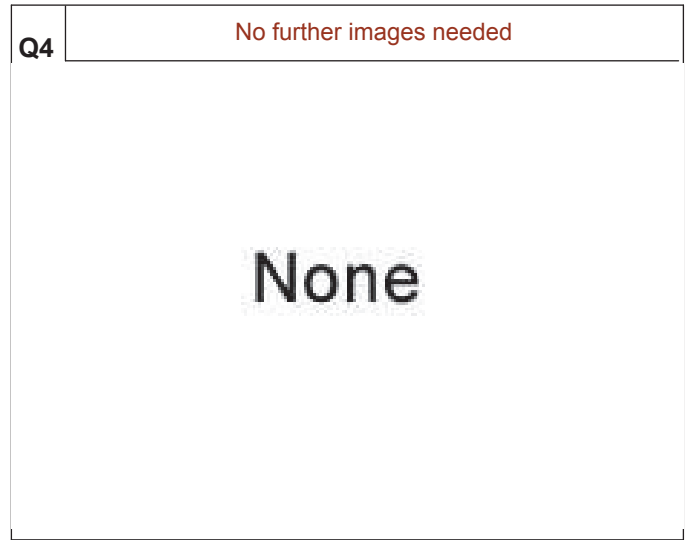
